
# **Register of Duties and Relevant Interests**





## Scope of Register

In accordance with the Trustee's Conflicts Management Framework, the Register of Duties and Relevant Interests captures actual, perceived and potential conflicts of duty and interest which may arise for the REI Superannuation Fund Pty Ltd, the trustee of REI Super, and for its Responsible Persons and employees.

## **Identifying the Type of Conflict**

#### A conflict can be either:

- a. A conflict of duty where the Trustee, or a Responsible Person or employee of the Trustee, owes a duty to another person or entity, which if performed, might reasonably be considered to have the potential to have a material impact on the capacity of the Trustee, or the Responsible Person or employee of the Trustee, to act in a manner that is consistent with the best interests of the members of the Fund.
- b. A conflict of interest where the Trustee, or a Responsible Person or employee of the Trustee, receives an interest, gift, emolument, or any other benefit or advantage, whether monetary or not, directly or indirectly, in connection with the provision of a service or product, which if received, might reasonably be considered to have the potential to have a material impact on the capacity of the Trustee, or a Responsible Person or employee of the Trustee, to act in a manner that is consistent with the best interests of the members of the Fund.

## Identifying the Nature of the Conflict

## A conflict of duty or interest can be:

- a. An actual conflict there is a conflict of duty or interest which exists.
- b. A potential conflict there is the potential for a conflict of duty or interest to arise in certain circumstances.
- c. A perceived conflict there is a situation where a third party, who may not be privy to all relevant information in relation to the situation at hand, may perceive that a conflict of duty or interest exists.
- d. No conflict no conflict of duty or interest exists.

## **Identifying the Materiality of the Conflict**

The three categories of materiality are:

- a. Material conflict there is an actual, potential or perceived conflict that in the reasonable opinion of the Group Executive Governance Risk & Compliance is likely to:
- Have a material consequence for the Trustee or a Responsible Person or employee of the Trustee; or
- Have a material consequence for one or more members of the Fund; or
- Result in a material breach of the Trustee's Conflicts Management Framework.
- b. Manageable conflict there is an actual, potential or perceived conflict that in the reasonable opinion of the Group Executive Governance Risk & Compliance is likely to:
- Have a manageable consequence for the Trustee or a Responsible Person or employee of the Trustee; or
- Have a minor consequence for one or more members of the Fund; or
- Result in a minor or technical breach of the Trustee's Conflicts Management Framework.
- c. Immaterial conflict there is an actual, potential or perceived conflict that in the reasonable opinion of the Group Executive Governance Risk & Compliance is likely to:
- Have no more than an insignificant consequence for the Trustee or a Responsible Person or employee of the Trustee; or
- Have no more than an insignificant consequence for one or more members of the Fund; or
- Result in no breach of the Trustee's Conflicts Management Framework.
